Schedule 11: Significant Accounting Policies & Notes to the Accounts

A. About the Company

Nepal Swimming Association (NSA) is a Not-For-Profit Sports Association (Organisation) registered under Sports Development Act 2048 at National Sports Council having the PAN 606169840. NSA is also registered in World Aquatics, International Swimming Federation (Old Name: FINA, Fédération Internationale de Natation). The main objective of the Organisation is to Promote, Represent and Execute all Aquatics Sports Activities Including Swimming and Other Discipline Defined by World Aquatics (FINA).

B. Significant Accounting Policies

1) Accounting Convention:

The financial statements are prepared under historical cost conventions on an accrual concept unless otherwise stated and are in accordance with NAS and other laws prevalent in Nepal. The Accounting policies are consistently applied by company.

2) Use of Estimates:

The preparation of financial statements in conformity with generally accepted principles requires estimates and assumptions to be made that affects the reported amounts of assets and liabilities and disclosures of contingent on the date of financial statements and the reported amount of revenues and expenses during the reporting period. Differences between actual results and estimates are recognized in the periods in which the results are known/materialized.

3) Fixed Assets:

- i) Fixed Assets other than land is stated including all expense up to the commissioning/putting the assets to use, less depreciation.
- ii) Depreciation is provided on the written down value method at the following rates:
- iii) Amortization on Software is Charged on 5 year Straight Line Basis.

Expenses are recognised on accrual basis
